Release of US ADP and NFP Employment Data – June 2025

Please be advised that the United States is scheduled to release the following key economic data at the specified Beijing times:

Key Data	Release Time	Previous (00,000s)	Forecast (00,000s)
ADP Employment Change	July 2, 2025, 20:15	3.7	12.1
NFP Non-Farm Payrolls	July 3, 2025, 20:30	13.9	13

Given the potential for heightened market volatility and reduced liquidity during the release of significant economic data or news events, substantial price fluctuations or insufficient market liquidity may occur in the 30 minutes prior to and 15 minutes following the data release. To safeguard your trading activities, we may implement the following adjustments based on prevailing market conditions:

Pending Order Distance Adjustments:

- **London Gold:** Pending orders may need to be placed at least 1,500 points away from the market price.
- **London Silver:** Pending orders may need to be placed at least 2,000 points away from the market price.

Spread Adjustments:

- **London Gold/Silver:** spreads may widen to 200 points or higher.

Important Reminders:

1. The release of significant economic data may lead to substantial price movements in gold and silver markets. We recommend prudent position management, setting appropriate stop-loss and take-profit levels to mitigate risks and capitalize on market opportunities. Please closely monitor market dynamics and seek timely professional market analysis and guidance.
