According to the latest updates, the United States will release key economic data at the following times (Beijing Time):

Data Type	Release Time (Beijing)	Previous (K)	Forecast (K)
ADP Employment	July 30, 2025 - 20:15	-33.0	57.0
Non-Farm Payrolls	August 1, 2025 - 20:30	147.0	132.0

During the release of major economic data or significant news events, markets often experience heightened volatility and reduced liquidity. In particular, from **30 minutes before** to **15 minutes after** the data release, such fluctuations may be pronounced. To ensure trading security and risk control, we will implement the following **temporary trading adjustments**, based on real-time market conditions:

Pending Order Distance Adjustment:

- **Gold (XAU/USD):** Minimum 1500 points from the current market price
- **Silver (XAG/USD):** Minimum 2000 points from the current market price

- **Gold/Silver spreads** may widen to **200 points or higher**
