Important Reminders:

1. During market closure on public holidays and weekends, market liquidity and volatility may be affected, potentially causing significant price fluctuations when the market reopens. 2. To safeguard your positions, we recommend that you **ensure your account has sufficient funds and maintain a margin ratio of 200% or higher before 00:15 on Jul 4, 2026 (Saturday)**. If your account margin is insufficient, the system may trigger a forced liquidation mechanism to meet the relevant margin requirements.
3. During market closure, all pending orders, stop-loss and take-profit instructions remain effective until you cancel them or they expire.
