在公佈重要數據或新聞前後，特別是在公佈前 30 分鐘至公佈後 15 分鐘內，市場波動通常較大且流動性下降。為保障您的交易安全，我們將根據實際行情，進行以下臨時調整：

1. 掛單距離調整（國際節日除外）

現貨黃金：掛單需距離當前市價最少 1,500 點；

According to the latest updates, the United States will release key economic data at the following times (specified in Beijing Time):

Data Type	Release Time	Previous (in thousands)	Forecast (in thousands)
ADP Employment	20:15 on 2 Sept	44.0	39.0
Non-Farm Payrolls	20:30 on 4 Sept	-23.0	60.0

During the release of important data or news, particularly from 30 minutes before to 15minutes after the announcement, the market usually experiences higher volatility and reduced liquidity. To enhance your trading security, we will make the following temporary adjustments based on the actual market conditions:

1. Pending Order Distance Adjustment:

- **Gold (XAU/USD):** Minimum 1,500 points from the current market price
- **Silver (XAG/USD):** Minimum 2,000 points from the current market price

2. Widened Spreads:

- **Gold/Silver spreads may widen to 200 points or more**

Important Reminders:

1. Significant price fluctuations may occur during the data release. Please manage your positions carefully and set appropriate stop-loss and take-profit levels to mitigate risk.
